Vision:

Mission:

Strategic Goals:

Goal #1: Establishing a good quality culture in the university:

Aims:

1. promote the concepts of quality to increase the awareness of the university community to the subject of quality

- a. Organizing workshops and seminars in order to develop the capacity and experiences of the University's staff toward the quality topic.
- b. Organizing annual and semi-annual surveys for the academic and administrative staff as well as the students in order to promote the quality culture among participants.







Goal # 2: Advancing the standard of quality at the academic, administrative, scientific research and community service at the university with the participation of all University employees.

Aims:

1. Establishing the needed human resources capacity building programs to achieve excellence and innovation

Strategies:

- a. Identify the training needs for the employees in the field of quality.
- b. Rehabilitation of specialists in different and implemented quality system at the University.
- c. Stimulate establishing cooperation partnerships, locally and globally, with the relevant authorities in the field of quality.
- d. Provide the University departments with the needed assistant to develop plans and strategies for staff training and raising their efficiency.
- 2. Activating the participation of staff members and students in the field of quality in the university:

Strategies:

- a. Forming the needed quality assurance committees at the academic programs and colleges' level.
- b. Encourage the involvement of students in quality committees the academic programs and colleges' level.
- c. Forming the needed quality assurance committees at the administrative departments' level.
- 3. Improving the administrative services that are provided to University beneficiaries:

- a. Encouraging all university departments to develop their own vision, mission and goals that should be consistent with the University vision and mission.
- b. Encouraging all University departments to develop their own strategic plan that should be consistent with the University strategic objectives.
- c. Re-structuring the organizational structure for the university to fit the needs of the university strategic plan.







- d. Provide the needed assistance to administrative departments to prepare the "standard working procedures' document".
- 4. Improvement and Development of Scientific research level at the University:

Strategies:

- a. Connecting the scientific research performance for each faculty member, as an evaluation standard, with the career promotion.
- b. Development of rewards and incentive awards for scientific research.
- c. Strengthen the sabbatical leave system at the University.
- 5. Raise the level of quality at the academic process:

Strategies:

- a. Forming quality committees at the academic programs and colleges' level.
- b. Improving Course level Self-evaluation forms.
- c. Improving Self-evaluation forms at the course, academic program and college level.
- d. Define the list of intended learning outcomes at the course level.
- e. Improve the students evaluation process according to the achievements of intended learning outcomes.
- f. Unify the course syllabus form for all University courses.
- g. Defining and continuously updating the graduate attributes at the program, college and university level.

Goal # 3: adopting and implementing local, regional and international quality standards, taking in consideration the specific needs and condition of the University:

Aims:

1. Implement the Accreditation and Quality Assurance Commission standards:

- a. Updating the annual reports for programs, faculties and courses in order to be relevant with the AQAC standards and terms.
- b. Insure the fulfillment of the ongoing programs and faculties to the requirements and terms of the AQAC.







2. Implement international academic quality standards:

- a. Implement international Quality standards at all administrative and academic departments.
- b. Implement international Quality standards at the academic, administrative and services departments' level.
